- You should maintain minimum standards of the quality of education, environment of the campus of the college, infrastructural and instructional facilities to the pupils and further to develop the facilities for imparting education in future years.
- The University has granted extension of temporary conditional affiliation to the College for a period of one academic year only i.e. for 2019-20 only.

- The syllabus prescribed by the University for the above courses is placed on the University 7 Web site and advised to watch regularly the University website for any information.
